Law Enforcement Identification Number Inspection

Instructions

This form is void if not submitted within 30 calendar days of the inspection unless submitted with a valid court order; in which case the form is valid for 30 calendar days after issuance of the court order.

If this form is used for identification number verification without applying for an assigned or reassigned number, this completed form should be submitted to the requesting county tax assessor-collector's office or the Texas Department of Motor Vehicles (TxDMV), as applicable.

If this form is used to apply for an/a:

- Assigned Number: This completed form must be submitted by mail or in person to your nearest TxDMV Regional Service Center with evidence of ownership, photograph of the vehicle, and a \$2.00 processing fee.
- **Reassigned Number:** This completed form must be submitted in person to your nearest TxDMV Regional Service Center with evidence of ownership, a \$2.00 processing fee, and the vehicle must be physically present at the time of application for installation of the number.

Mailed fees should be in the form of a personal check, cashier's check, or money order payable to TxDMV. **Do not mail cash.** Credit/debit cards and temporary checks are not accepted. **Fees are non-refundable.**

If an identification number is assigned or reassigned to your vehicle, you will be provided a copy of this form and an original *Notice of Assigned or Reassigned Identification Number* (Form VTR-68-N). The copy of Form VTR-68-A and the original Form VTR-68-N must accompany the title application when submitted to your county tax assessor-collector's office.

Inspection Fee: An inspection fee of up to \$40.00 may be charged at the time of inspection.

Important - Original Manufacturer's Vehicle Identification Number

If law enforcement is unable to determine the original identification number or component part number, the department will assign a number if this form is accompanied by valid evidence of ownership in the name of, or properly assigned to, the applicant.

If law enforcement is able to determine the original identification number or component part number, the department will reassign the original manufacturer's identification number if this form is accompanied by valid evidence of ownership in the name of, or properly assigned to, the applicant.

Trailer/Semitrailer Definitions

Trailer: designed or used to carry a load completely on the trailer's own structure and is drawn by a motor vehicle. **Semitrailer:** designed or used so part of the weight of the semitrailer and its load rests on or is carried by the pulling motor vehicle.
